NOTICE IS HEREBY GIVEN, pursuant to Section 1104 of the Indenture dated as of February 7, 2012 (the "Base Indenture"), between Medley Capital Corporation, a Delaware corporation (the "Company"), and U.S. Bank National Association (the "Trustee), and Section 101(h) of the Second Supplemental Indenture dated as of March 18, 2013 (the "Second Supplemental Indenture," and together with the Base Indenture, the "Indenture"), that the Company is electing to exercise its option to redeem, in part, the 6.125% Notes due 2023 (the "Notes"). The Company will redeem \$13,000,000 in aggregate principal amount of the \$102,846,800 in aggregate principal amount of issued and outstanding Notes on March 10, 2018 (the "Redemption Date"). The redemption price for the Notes equals \$25 in principal amount per Note being redeemed (or \$13,000,000 in aggregate principal amount of the Notes), plus the accrued and unpaid interest thereon from December 30, 2017, through, but excluding, the Redemption Date (the "Redemption Payment"). The aggregate accrued interest on the Notes payable on the Redemption Date will be approximately \$154,827 (or approximately \$0.298 on each \$25 principal amount of the Notes).

On the Redemption Date, the Redemption Payment will become due and payable to the Holders of the Notes selected for redemption. Interest on the \$13,000,000 in principal amount of Notes being redeemed will cease to accrue on and after the Redemption Date. Unless the Company defaults in paying the Redemption Payment with respect to such Notes, the only remaining right of the Holders with respect to such Notes will be to receive payment of the Redemption Payment upon presentation and surrender of such Notes to the Trustee in its capacity as Paying Agent. Notes held in book-entry form will be redeemed and the Redemption Payment with respect to such Notes will be paid in accordance with the applicable procedures of The Depository Trust Company.

Capitalized terms used but not defined herein shall have the meaning ascribed to them in the Indenture.
